This Pretrial Order shall supersede all pleadings, shall control the subsequent course of this case and shall not be modified except by consent of the parties with Court approval or by order by the Court on its own Motion to prevent manifest injustice.

The Court finds that this case is at issue; however, all discovery may not be complete. Completion of any additional discovery will not delay the trial of this case.
